Coursework

This course is nationally accredited qualification. The purpose of this course is to ensure that all persons involved in the field of investigations are suitably trained and qualified to perform their task in a professional manner.

The licensing regulations requires that all persons applying for a private investigator license complete the Certificate III in Investigative Services with an accredited Registered Training Organisation.

There are two primary methods of investigations that are covered in the Certificate III.

Surveillance/Activity Review – involves close observation, be it overt or covert, of a person or group who are under suspicion.

Circumstance/Factual Investigation – involves making enquiries in to the facts of an incident. For example; interviewing people who are of interest to the courts or insurance companies.

Career Options:

Qualified Private Investigators have the opportunity to work in multiple industries, and with multiple identities. The investigator role is an exciting career option, as you can work undercover to determine possible foul play, this can be in the construction, government, council or private organisations. Investigators may need to work in a team trying to determine if there is unlawful activities within industry.
