Coursework & Assessment

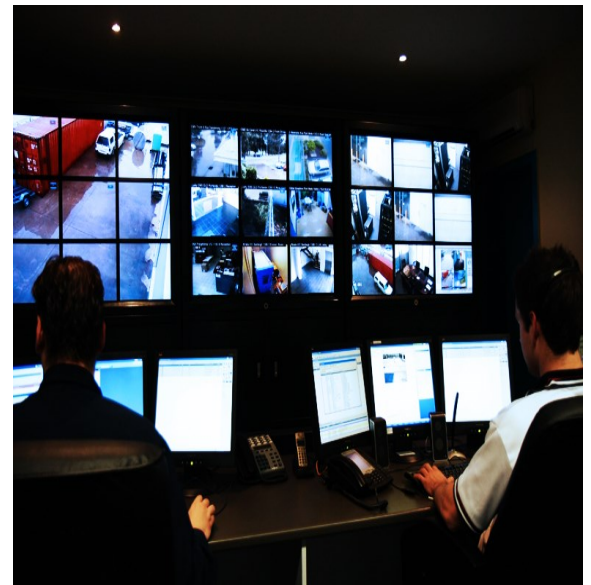
